Terms And Conditions

Liability, The Breeder does not assume any liability for any injury to the puppy after the Adopter takes possession of the puppy. The Adopter agrees to have this puppy examined by a veterinarian within 72 hours of taking possession to assure the Adopter that the puppy is healthy.

If the puppy is found to be other than healthy (excluding worms, coccidia, giardia or any other parasites common in puppies) at said veterinary visit, the puppy shall be returned to the Breeder immediately and will be exchanged for another puppy when one becomes available at discretion of breeder. Written confirmation of health concern from the veterinarian is required.

The puppy has had appropriate vaccinations and parents have had DNA Testing for specific Breed a record of DNA, vaccinations, deworming, and microchip information will be supplied to the Adopter and is registered with OFA and UC Davis Links are on Web Site.

Registration & Price, this puppy is purebred and may be registered with Full Registration or limited registration through the American Kennel Club. Full Registration included with full price purchase or bought separately (only). will allow breeding and registering offspring as well as being eligible to show in the breed ring. All puppies will include Standard Limited Registration unless buyer chooses to have full registration otherwise limited is automatic and does not allow breeding or registering offspring. The puppy is ineligible to show in the breed ring, but it may compete in other events such as Obedience, Tracking, Field Trials, Hunting Tests, Herding, Lure Coursing, Agility and Earth. Some adopters prefer not to breed their dog and opt for limited registration as it will be a family pet it is encouraged to have the dog spayed or neutered with limited registration.

Included in purchase, The Adopter will be supplied with an application for AKC registration at the time that possession is taken however the puppy will be registered to the adopter online by the breeder at time of or before transfer of the puppy at no additional cost, also included with full price purchase only (no Discounts or Coupons) is life time AKC reunite microchip, 30 days pet insurance (puppy must be 8 week of age or older for pet insurance), Custom Home Pet Care Package a gift from the breeder (This is mailed to adopter and is custom made for each puppy), A copy of the puppy's Medical Records, 3

year pet health guarantee is given at time of pick up or emailed. The puppy's Temperament, breed ability and conformation of the puppy are NOT guaranteed.

Adopter Responsibilities, The Adopter agrees to maintain the puppy's health in good condition, feed a high-quality food, maintain good weight control, and provide yearly health examinations, vaccinations/titers, heartworm tests and any other usual procedures necessary to assure good health. The Dog shall reside with the Adaptor. The Adopter Shall Provide the Dog with: Adequate Food, Fresh Water, Shelter, Affection, and appropriate medical care, which should include an annual health exam and routine vaccinations as recommended by a board-certified veterinarian.

A fully Fenced Yard or Other humane means of exercise. The dog shall not be continually chained. Never permit the dog to roam unattended. The Adopter agrees that this puppy will not be sold, or ownership transferred without the Breeder's knowledge and consent.

Lifetime Rehoming; The Adopter agrees that if at any time proper care cannot be given to the puppy, the Adopter must contact the Breeder. The Breeder will have the option either to take the puppy back or to assist the Adopter in placing the puppy in a suitable home for the Lifetime of the dog the Adopter may return the dog to autumn's goldens at any time and for any reason. If the adopter returns the dog, the adopter shall sign the necessary papers to make autumn's goldens the sole owner of the dog.

Pet Health Guarantee from the breeder is as follows the breeder has taken every reasonable precaution to prevent this puppy from acquiring hereditary diseases. The Breeder Guarantees If a genetic life threatening problem is found that the breeder has DNA tested parents for within 3 years from the time of dog's birth, the adopter may return the dog for another puppy that will be given when one becomes available or refund at the discretion of the breeder this guarantee excludes cancers of any kind, Vaccines or medication of any kind given to the puppy at any time from time of birth onward. any genetic issues the breeder has not tested for, natural or accidental death, non-life threatening genetic or common conditions, diseases of any kind of the dog the breeder may or may not have tested for, any and all environmental factors and/or improper care of the puppy that are out of the breeders control the breeder will not guarantee.

Should this puppy develop Hip Dysplasia (Mild, Moderate or Severe), Elbow Dysplasia, Subaortic Stenosis, or Cataracts deemed hereditary by the 24th month of the puppies birth date, the Breeder will take the puppy back and replace it with a puppy of equal value as soon as available and/or a refund at the discretion of the breeder. Costs to return and receive replacement puppy are at the Adopter's expense and; therefore, No replacement will be given if the puppy has not been examined by the 24th month of the puppies birth date. Hip and/or Elbow Radiographs must be submitted to and examined by the Orthopedic Foundation for Animals and results must be supplied to the Breeder. Sub-aortic Stenosis must be confirmed by Echocardiography and Doppler performed by a Board-Certified Veterinary Cardiologist and documents must be supplied to the Breeder. Eye exams must

be performed by a Board-Certified Veterinary Ophthalmologist and documents must be supplied to the Breeder. Environmental factors, like high caloric diet during the rapid growth phase, may exacerbate changes in dysplastic hips or elbows. Therefore, the Breeder refuses to take responsibility for dysplasia in an overweight puppy and thus Adopter will not qualify for a replacement puppy. Veterinarian records must be made available to prove good weight control. No replacement or refund at the breeder's discretion will be given if the puppy has not been examined within 72 hours of receiving the puppy.

Refunds & Payments, Deposit Down payment, Payment plans, or partial payments Are Non-Refundable. refund or replacement of puppy is only available with full payment of puppy and applicable to terms of adoptions agreement and/or at breeders' discretion and final decision.

Purchase Agreement, the adopter (buyer) upon verbally agreeing to purchase a puppy and/or in making payment of any amount and/or checking the box for terms and conditions upon check out. agrees to purchase the dog and pay in full the full sell price of the dog, if a down payment is made the adopter agrees to pay the remaining balance owed before and/or at date and time of pick up the breeder has set for the adopter(buyer) to take possession of the dog. The breeder(seller) will send out invoice for remaining balance due to the adopter and/or fees set out in section Abandonment Policy if applicable, the adopter (buyer) will make payment in full and/or Autumns Goldens reserves the right and permission to bill and charge all amounts due to any debit card, credit card, Bank account or other means the client (Buyer) has to make payment including means on file within 365 days from time of down payment, automatic billing is at breeders' (sellers) discretion.

Abandonment Policy: If the adopter fails to take possession of the dog within 5 days of the transfer Pick Up date set by the breeder and agreed upon by the Buyer. the dog will be considered abandoned, the dog will remain with the breeder and may be rehomed at the breeder discretion, the adopter will lose any and all claims and/or rights of ownership of the dog, The Adopter (Buyer) agrees to transfer registration ownership of the puppy back to the breeder if any transfers have been made. if the puppy has been registered or ownership transferred to adopter the adopter will be responsible for all fees to transfer the puppy back to the breeder and other cost associated in the initial transfer to adopter. the adapter (initial Buyer) gives full authorization to the breeder to make any changes to the registration including but not limited transfer of ownership of the puppy (Dog) at any time. the adopter will not be refunded any amount, or purchase price or deposits of any kind for the dog, furthermore any balance and or acquired fees, service fees, added expense, bills, owed or billed to the purchaser will owe that balance to the breeder as well as any collection fees, court cost and all other legal and/or attorney fees to obtain the balance owed to breeder as well there may be a 29% interest rate added to the balance until paid in full (this covers some cost of but not limited to additional cost that can be added for care, maintenance, handling and service charges, transport and recovery of

the puppy (Dog), billing and invoice charges, medical, medications, advertisements to rehome, boarding and housing fee's, Other fees and charges may also apply to balance. Autumn's Goldens has zero tolerance for abandonment of a Puppy or Dog or any animals.

Mistreatment Policy, If the adopter fails to comply with healthy treatment of the dog at any time and/or if the dog is neglected used for experiments, laboratory resource of any kind and or not being properly cared for by the terms of this agreement the breeder will have the full right to remove the dog from the adopter and take possession of the dog and transfer ownership back to the breeder, the adopter will not have any rights of ownership of the dog and will not be refunded or compensated for the dog, the adapter (initial Buyer) gives full authorization to the breeder to make any changes to the registration including but not limited transfer of ownership of the puppy (Dog) at any time. additional cost that can be added for care, maintenance, handling and service charges, transport, and recovery of the puppy (Dog), billing and invoice charges, medical, medications, advertisements to rehome, boarding and housing fee's, other fees and charges may also apply to balance and billed to the Adopter. neglect and mistreatment will be documented and reported to proper agency We have zero tolerance for anyone who abandons or mistreats a Puppy, Dog, or any animals.
